HEALTH CARE PROGRAM CHANGES

The 2012 Florida Legislature session is now in session as of January 10th. Protecting the Medicaid program for vulnerable Floridians is a top priorities for many nonprofit organizations dealing with health and human services. Georgetown University Health Policy Institute has published an issue brief on Medicaid and long term care in Florida to help us keep up with the Medicaid Reform pilot statewide and the changes that may lie ahead for long-term care providers and beneficiaries. Health and Human Services (HHS) rejected Florida's request in mid-December for a partial exemption from the medical lost ratio (MLR) provision. The MLR requires insurance companies to spend at least 80% of the premiums on activities directly related to patient care. Insurers who fail to meet the standard must send a rebate check to policy holders. As a result of the HHS decision. Florida health care consumers could see more then \$140 million in total rebates over the next three years. HHS officials cited a petition that over 3000 health care consumers from across the state signed, and a letter from 10 advocacy groups as the most consumer input they received on a waiver request like this.
